Re: Vocal Music Recommendation – Carrie Gruman-Trinkner

This memo is to recommend Ms. Carrie Gruman-Trinkner for the 1.0 FTE vocal music teaching position for the 2020-21 school year. This is a K-12 position with a presence at both the Manawa Elementary School, Manawa Middle School, and Little Wolf High School

Ms. Gruman is coming to Manawa from the Montello School District. She was only an employee of the school district for a brief period after returning from Brooklyn, New York. Her discovery of the vocal music opening and her desire to come back to the Manawa area drove her decision to apply for the position.

With thirty-two years of teaching experience, the School District of Manawa is fortunate to acquire a highly qualified candidate in late August. Ms. Gruman is very familiar with central Wisconsin. Previous employment in this immediate area includes the Director of Choral Activities at Pacelli Middle and High School from 2014-2017, Weyauwega-Fremont from 2004-2014, and Kimberly High School from 1994-2003. Her most recent placement was at Brooklyn Dreams Charter School in Brooklyn, New York. She received her formal education and training from the University of Wisconsin – Platteville where she earned a Bachelor of Science in Music Education with an emphasis on 7-12 Choral Music and K-12 General Music. Additionally, Ms. Gruman is an accomplished accompanist, author, and has additional course work in the field of Autism Education.

Throughout her career, Ms. Gruman has demonstrated innovation, hard work, and creativity. Ms. Gruman has experience in teaching at all grade levels, directing musicals, plays, forensics, show choirs, madrigal dinners, vocal jazz ensembles, and percussion ensembles. Her groups have traveled both across the United States and traveled abroad to England, Ireland, Wales, Austria, and Germany. She enjoys performing musical theater and spending time with her family.

Pacelli Principal Larry Thiess states, "Carrie's creative skills are amazing, and I enjoyed working with her. She has great passion and vision and provided outstanding music education for our students." Two candidates were selected for first-round interviews with a committee comprised of various staff members. Ms. Gruman moved forward to the administrative team interview and received the full endorsement of both interview teams. Mr. Austin Rohan, the current instrumental music teacher, was present for all first-round interviews. I strongly recommend Ms. Carrie Grunman-Trinkner for the 1.0 FTE vocal music teaching position for the 2020-21 school year.

Re: Fans in the Stands Recommendations

The purpose of this memo is to provide information and recommendations regarding home fan attendance at athletic events for the start of the 2020-2021 school year. The SDM Board of Education is applying local control as it pertains to their fan attendance policy.

The guiding principles that shape this recommendation include:

- 1. Providing for the safety of our student-athletes, coaches, and officials.
- 2. Limiting total exposure via a reduced capacity of fans.
- 3. Honoring the wishes of the Manwa community to take necessary precautions to enable students to continue with in-person academic instruction.

At this time for fall sports, we are recommending only home fans at our events. The home fans would be limited in number as follows:

- Indoor events (volleyball) each competitor, paid, and volunteer coach will be allowed two tickets for fans.
 Tickets issued to student competitors must be used by family members only (and may not be given to student-aged friends within or outside of the District). The parents may bring other children using the available tickets, are able to comply with the face-covering requirement, and remain seated in the family group.
- Outdoor events (football) each competitor and paid and volunteer coach will be allowed four tickets for fans. Tickets issued to student competitors must be used by family members only (and may not be given to student-aged friends within or outside of the District). The parents may bring other children using the available tickets, are able to comply with the face-covering requirement, and remain seated in the family group.
- Athletes who are a member of the team but not suited up for competition will be granted a single ticket to attend the event and be present in the stands.
- Student tickets will be available through a lottery system. Criteria for consideration of the ticket lottery include:
 - 1. Students must be participating with the In-person or a principal approved Blended Plan Mode of Instruction.
 - 2. Students must be passing all classes, and not have any Incompletes from 2019-2020.
 - 3. Students must not be on truancy watch.
 - 4. The first opportunity for student lottery tickets will be given to seniors.

Special Note - Student attendance at sporting events is a privilege so proper conduct is expected. Anyone not following district/school expectations will lose the privilege of participating in the lottery.

Additional Considerations:

- The number of student lottery tickets will be 50 for outdoor sports. The number of student tickets for indoor events is yet to be determined. (Tentative 50)
- All fans will be expected to wear proper face masks/coverings and to follow the social distancing guidelines when attending home sporting events.
- There will be no concessions sold and carry-ins will not be allowed.
- The media will be admitted to a designated area by the A.D. and will not be allowed on the field/court with the players and coaches.
- Sporting events will be live-streamed (free) so those who cannot attend in person will be able to watch the contests.
- Non-H.S. students/children who attend athletic events with their families will be expected to stay in the stands with their family for the events and must have a school-issued ticket.
- All persons regardless of age will need to have an issued ticket.

*Middle School events will follow the same protocol for student attendance at Middle School Athletic Events.
